RESEARCH:

The use of a multi-vitamin supplement is supported by a comprehensive report issued by the Council for Responsible Nutrition. The report found that ongoing use of multi-vitamins and minerals demonstrated a quantifiable positive impact in areas ranging from strengthening the immune system of highly vulnerable elderly patients to drastically reducing the risk of neural tube birth defects such as spina bifida. This report was written based on the review of a decade's worth of the most scientifically significant studies measuring the health benefits of multi-vitamins and other nutritional supplements. One of the report's findings states, "The routine use of multi-vitamin and mineral supplements by the elderly could improve immune function and thus reduce infectious disease, potentially cutting in half the total number of days they are sick."

SIDE EFFECTS:

This formula is generally safe at the recommended dose for people who require iron supplementation. The toxicity of iron is low, and harmful effects of daily intakes of up to 75 mg in healthy individuals are unlikely. It is possible, though rare, to get too much iron, leading to a condition known as hemosiderosis.
